

## MEDINA JULY 4<sup>TH</sup> PARADE REGISTRATION 2009

The Medina Breakfast Kiwanis and the City of Medina invite you to participate in July 4<sup>th</sup> Parade.

Due to the ever-increasing number of vehicles and floats in this parade and the lay-out of the staging parking lot, Sidney Fenn Elementary School can no longer accommodate the traffic and pedestrians. **The parade will be staged in the Medina High School parking lot on East Union Street (across the street from Sidney Fenn).**

There will be assigned rows for all participants and organizations pre-registered for the parade. Row assignments will be given to each participant the day of the parade. No organization or person will be denied the ability to participate but those that do not pre-register will be placed in the order of their arrival **behind** those who have pre-registered.

The parade will begin **promptly** at 6 PM from the High School parking lot, headed south on Spring Grove, then west on Liberty and around the square (see attached map). The parade will end in the back parking lot of the County Courthouse. For safety purposes, no candy is to be thrown from moving vehicles. Please notify all participants in your entry.

### **To pre-register:**

1. Complete one entry form per group. If you have more than one vehicle or if you want to be in line with another participant, please indicate that on the registration form. For example: Medina Youth Baseball – two cars, one float and approximately 50 participants.
2. Copy the release form and have each participant, parent and/or guardian complete and sign the form. These forms will need to be turned in with the pre-registration forms. No one will be permitted to be in the parade without first completing the form.
3. **Return the information (entry forms / release forms) by June 30, 2009 to the Mayor's Office located at Medina City Hall, 132 N. Elmwood Avenue, Medina, Ohio 44256.**
4. On the day of the parade, please arrive at the High School parking lot between the times of 4:30 PM and 5:40 PM and park in your assigned row / space.
