

**ORDINANCE NO. 71-15**

**AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT SEVENTEEN (17) EASEMENTS NECESSARY FOR THE RYAN ROAD SIDEWALK PROJECT, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:**

- SEC. 1:** That the Mayor is hereby authorized to accept seventeen (17) Easements necessary for the Ryan Road Sidewalk Project, City Job #962.

- SEC. 20:** That this Ordinance shall be considered an emergency measure necessary for the immediate preservation of the public peace, health and safety, and for the further reason to pay the property owners as soon as possible; wherefore, this Ordinance shall be in full force and effect immediately upon its passage and signature by the Mayor.
