NOTICE OF BID

Sealed bid proposals will be received by the Mayor of the City of Medina, Ohio in his office at 132 N. Elmwood Avenue, Medina, Ohio 44256 until 10:00 AM local time on Friday, June 10, 2016 for the furnishing of all labor, tools, materials, equipment and supervision necessary for the project known as "WEST SMITH ROAD RECONSTRUCTION PROJECT", City of Medina Project Number 818, at which time bids will be publicly opened and read. Bids must be submitted on the forms provided by the City and placed in a sealed envelope with the name of the Project, the name of the bidder and the bid date and time clearly marked on it.

Contract documents, bid documents, plans and specifications can be obtained at the Office of the City Engineer at 132 N. Elmwood Avenue, Medina, Ohio 44256, between the hours of 8:00 AM and 5:00 PM weekdays beginning on Thursday, May 19, 2016 for \$80.00 per each set. Checks shall be made payable to the City of Medina. Refunds will be made for contract documents returned to the City Engineer in good condition within ten (10) calendar days of the bid opening.

The Engineer's estimate is \$3,592,853.00. The final completion date for the project is July 14, 2017; however, the bidder's will be given the opportunity to submit an earlier completion date, if they desire. Completion date will be one of the factors utilized by the City of Medina when evaluating bids. The bidder must submit a completion date with the bid submitted.

This project is partially funded by federal funds through the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). As such, contractors must be ODOT pre-qualified at the time of bidding, the time of sale, the time of award, and through the life of the construction contract. A six (6) percent Disadvantaged Business (DBE) goal has been set for this project.

Each bid must be accompanied by a Certified or Cashier's Check, or a bid bond, in the amount of 10 percent of the total amount bid, made payable to the City of Medina, Ohio and the Ohio Department of Transportation as guarantee that, if the bid is accepted, a contract will be entered into with the City within thirty (30) days and its performance secured by a performance bond in the amount of 100 percent of the contract price, and in default thereof, said check or bond will be forfeited to the City of Medina as liquidated damages.

A voluntary pre-bid meeting will be held at 10:00 AM in the Rotunda of Medina City Hall, 132 North Elmwood Avenue, on Wednesday, June 1, 2016.

The City of Medina reserves the right to reject any and all bids and the right to waive any informalities or irregularities in the bidding. Contact the City Engineer at (330) 721-4721 for further information.
