## **COVID-19 Press Release March 23, 2020**

**Medina, Ohio-** Due to the recent Stay at Home order issued by the Ohio State Health Department, Medina City Hall will be closed effective immediately. Appointments to meet with staff will be required. Any items that may be submitted electronically or mailed are preferred. A box or bin will be provided in the vestibules at both entrances to leave written correspondence for any city department. It will be distributed regularly. Payment for City water bills, Armstrong bills, and Medina County Sanitation bills can be deposited in the utility drops in the Medina Municipal Court lot.

If emergency and access are needed without an appointment, numbers will be posted at inner city hall doors to call office and ask for immediate help. Essential services to constituents, such as police and fire protection or water main breaks, will be maintained, but some services such as fence permits, pool permits, etc. will be deferred. These efforts are being taken to limit exposure of public to staff and vice versa.

City Council will have both the Finance Committee meeting and the Council meeting in the Rotunda to permit recommended spatial distances for Council, the Administration and the public. Remote access to the meetings rather than physical attendance, for the public may be accomplished by following the below process:

### **Steps to watch City Council Meetings from home:**

2. The meeting will not appear until we go live so if you log in early please be patient
3. Then watch the meeting

8. The meetings will also be televised live on MedinaTV Channel 37

10. Replays are also available on Channel 37 of Armstrong Cable
11. Facebook will also offer on demand replays once the live feed has finished broadcasting
