I also realize that updating this information is solely my responsibility, and I hereby release all other parties from any and all responsibility. I agree to read the Medina Community Recreation Center Membership Handbook, and will ask any necessary questions so that I fully understand the rules and regulations of the facility and the Memorial Pool and recognize that it is my responsibility to adhere to all MCRC and Memorial Pool policies and procedures. I realize that failure to abide by these rules can be grounds for membership suspension or termination without a refund. I understand that this Agreement is binding on me, my legal representatives and heirs. Authorization is also given to the City of Medina, the MCRC and the Medina Parks to release the information on this application to emergency callers.
