Student: Person who is 18 - 25 years of age with a tuition statement or course schedule (current term)

Senior: Person who is 60 years of age or older

2-Person: Two adults (ages 18-59) who reside in the same household

Family: Parent, legally married parents, or guardian, all children (3-17 years of age and younger), and all college students (18-25 years of age) residing in the same household. This fee is established for up to 5 family members (\$35 for each additional member).
