### **Conditional Sign Permit Review guidelines**

- The Conditional Sign Permit Review guidelines in §1147.16 state that the proposed sign must be compatible with the design and materials of the building on which the sign is to be placed.
- The guidelines state that the proposed sign must be harmonious and in accordance with the general character of the district:

Sign Area. Signs must conform to the sign regulations outlined in Chapter 1147.

• Ground signs must be a maximum of 12 sqft and 6 feet tall in the Historic District and must be setback at least 5 feet from the front property line along S. Broadway St.

#### **Staff Comments:**

The proposed signage is compatible with the district, the building and the conditional sign guidelines and complies with the applicable sign code regulations.

#### Recommendation:

Staff recommends the Historic Preservation Board grant a conditional sign approval for the proposed ground sign at 209 S. Broadway St.
