Project introduction:

The applicant requests new window signage and projecting sign for a relocating Medina business – House of Flowers. The proposed window signage is the business logo and 4.9 sqft. The projecting sign will be 4 sqft and mounted at least 8 feet above the public sidewalk.

Considerations:

Conditional Sign Permit Review guidelines

- The Conditional Sign Permit Review guidelines in §1147.16 state that the proposed sign must be compatible with the design and materials of the building on which the sign is to be placed.
- The guidelines state that the proposed sign must be harmonious and in accordance with the general character of the district:

Sign Area. Signs must conform to the sign regulations outlined in Chapter 1147.

- Permanent window signage is calculated at one sq. ft. of sign for every one linear foot of store frontage with a maximum 25% coverage of the window on which it is affixed. The proposed 4.9 sqft window sign complies
- The proposed 4 sqft projecting sign complies.

Sign Location: Section 1147.15(e) states that projecting signs shall be located not more than 14 feet above finished grade as measured from top of sign, and shall maintain a minimum vertical clearance of 8 feet from bottom of sign to finished grade. The proposed projecting sign plan complies.


Staff Comments:


